





#### Figure 1: Current Derating, Case






Figure 3: Typical Forward Voltage



**Figure 5: Typical Junction Capacitance** 






**Figure 4: Typical Reverse Current**

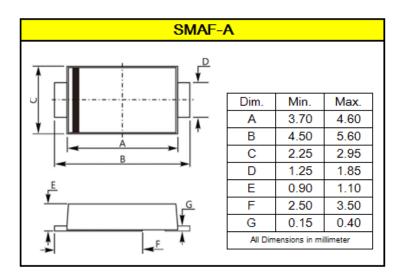



#### Mounting pad Outline Dimensions millimeters


